- 1. Applications for enrolment may be made at any time by the parent/carer(s).
- **2.** Students enrolling at the College (Kindergarten) for the first time will be <five years of age on or before 31 July.
- **3.** The College will base any decision about offering a place to a student on: Family relationship with the College:
  - Sibling of a current or ex-student;
  - Either of the parents attended the College
  - They hold attitudes, values and priorities that are compatible with the College's ethos

## The student:

- The contribution that the student may make to the College, including the cocurricular activities
- The student's reports from previous schools or prior to school service e.g. the NSW Department of Education's Transition to School Statement
- Students transferring from another Christian School

### The College:

- Ability to meet the special needs or abilities of the student
- Special circumstances at the Principals discretion
- **4.** The College may meet with the parent/carer(s) of the student before offering a place. Information from the students' previous school, including reference regarding attitudes and application towards learning, character, social and behavioural history may be sought following the receipt of application and before a determination on the offering of an interview or place is made.
- **5.** The College has absolute discretion in determining the weight of each of the factors it takes into account in determining whether to offer a place for the student. A placement can only be made if there are vacancies in the required year level.
- **6.** By accepting the offer of enrolment, parents agree to uphold and support the educational ministry of Summerland Christian College as contained in the policies accessible on its website (insert link). Failure to comply with the conditions of the enrolment agreement and accompanying policies may lead to the cancellation of your child's enrolment by the College executive. Any appeals to enrolment cancellations will need to be lodged with the College board within 7 days of the date of enrolment cancellation. After the written response from the family is received, the Board will then make a final decision, giving due consideration to the matters at hand and the merits of the case.
